The meeting was called to order by Chair Cris Lawrence at 7:02pm and a quorum was established.

Luke Bronin – He talked about the current political environment and how so many people have a sense of crisis about the future. Lawmakers are talking about changing it which will adversely affect a lot of Eastern CT towns. She mentioned other cuts to UConn and UConn health research grants, etc.

Old Business:

Board reports:

Charter Commission – They will be presenting their revisions to the Board of Selectmen at the 5/1/2025 meeting at 7pm.

Board of Finance – We talked about writing letters to the editor of the Rivereast which would've been due the next day 04/29/2025. It was suggested that the people most needed to reach don't really read the Rivereast though.

Dept. of Public Works (DPW) – The public voted at a town meeting to pass the initial half of the design's funding, approximately \$750,000

Board of Assessment Appeals – The motor vehicle tax formula is changing, Car valuations can be appealed by Hebron taxpayers.

Planning and Zoning – They approved a new mini golf course to be built at the new nursery across from Wild Bill's in 2026. We're getting 16 new apartments on Wellswood Rd, some of which will be affordable housing.

Adjournment: A motion was made to adjourn at 9pm by David Rose and seconded by Judy Podell. All were in favor.
